An increased cost of foreign currency in relation to the U.S. Dollar of more than 5% will be reflected in the final tour price. Price is per person on a double occupancy basis. Single Supplement is \$1400.00 and is on a Limited Basis. Tour includes: Private Escort from Pacific Horticulture; deluxe hotels; breakfast each day; transportation by private motorcoach; sightseeing as described in itinerary; entrance fees; local expert guides throughout; meals as listed; private visits with horticultural and other experts as described in itinerary; portorage of 1 bag per person; gratuities in restaurants.
